Re: Medicare 2019 Fee Schedule Final Rule

On November 1, 2018 the Centers for Medicare and Medicaid Services (CMS) released the final rule on the 2019 Medicare fee schedule. We will be providing three information alerts on the rule. This first on psychological and neuropsychological testing services, and next week on payment rates for psychotherapy and health and behavioral services and finally how the Merit-based Incentive Payment System will impact psychologists in 2019.

We are very pleased to say that **NEARLY ALL psychologists will see higher Medicare payments for psychological and neuropsychological testing services** in 2019!

The APA's Practice Organization projects that in 2019 a typical 6-hour battery, comprised of 3 hours of testing administration and scoring along with 3 hours of interpretation and evaluation testing services will increase by the following percentages:

- 6-hours psychological testing administered and evaluated by professional +13%
- 6-hours technician administered psychological testing w/ professional evaluation +21.2%
- 6-hours neuropsychological testing administered and evaluated by professional +2.5%
- 6-hours technician administered neuropsychological testing w/ professional evaluation +5.9%
- 1-hour of the neurobehavioral status examination +2%

APA Advocacy for Testing Codes

The APA's Practice Organization actively participated in the development and valuation of the new codes. This advocacy led to more specific coding options for testing services by psychologists and by technicians under the psychologist's supervision, which will be implemented on January 1, 2019.

These new codes were created through the American Medical Association / Specialty Society Current Procedural Terminology (CPT®), and recommended values for the new codes were sent to CMS by the

Resource-based Relative Value Update Committee (RUC). At the end of 2017, RUC had recommended substantially lower payment rates for testing services in 2019. The APA Practice Organization fought to increase the value of psychological and neuropsychological testing under the new codes.

We argued that if implementing the new codes resulted in reimbursement cuts Medicare beneficiaries would lose access to these critical services. CMS agreed and announced higher rates in the proposed rule. Now in the final rule CMS has gone even further than it first proposed in raising the value of testing services. Based on the comments submitted by the APA Practice Organization and echoed by nearly 190 psychologists in their individual comments, the agency realized psychologists and neuropsychologists who administered their own tests rather than using technicians would see reduced payments under the new testing structure. To remedy this situation CMS increased the clinical labor time for professionally-administered testing services, thus raising the services' overall value.

We in the Practice Organization want to thank the many psychologists who answered our call to action in July and wrote to CMS to urge higher payments for these services. Your comments made a difference!
